Saturday, Parent's night out is offered for a separate fee on select Saturday's throughout the school year 5pm-9pm for \$50.00 for 1 child and \$65.00 for siblings (2)

Fees due upon enrollment:

Registration: Per school year is \$150.00 per child, \$250.00 for siblings - Due at enrollment and re-enrollment of each new school year. (non-refundable)

Last week's tuition: Pays the child's last week with a 10-business day written notice. There are no refunds on the last week tuition, including if the child is not in attendance or 10- business day notice wasn't given. (non-refundable)

Cleaning fee: Per school year is \$35.00 and per family- Due at enrollment and re-enrollment of each new school year. (Non-refundable)

Tuition: tuition rates stated above are for 2020-2021 school year. There is an annual tuition increase at the turn of the new school year in August.

Tuition fees are calculated based on weekly attendance. Regular hours of operation are Monday through Friday, 8 a.m. to 6:00 p.m. Weekly payment is due on Friday at drop off. If Friday is a holiday, the payment is due on Thursday or the last business day of the week. A late fee of \$30.00 is due if payment is not paid by 6:00 pm. No payments will be accepted on the weekends. If payment and all fees are not paid in full at drop off by the first business day of the week, child care services will be suspended until account is paid in full. A \$15.00 per day late fee will accumulate for payments received after Friday. There is a \$25.00 return check fee. A returned check could require cash-only payments for future services.

Payment will continue to be due when the child is not in attendance for any reason; including illness, non-compliant health records, vacation, inclement weather such as tropical storms, hurricanes and emergency closings.

Soleil Early Learning Academy is closed for the following days and tuition continues to be due; Memorial Day, Independence Day, Labor Day, Thanksgiving and the Friday following. The center is closed for the week of Christmas and will re-open after New Year's Day .

Note: 10% sibling discount applies to older siblings tuition on fulltime tuition

Soleil Early Learning Academy will require all parents to obligate themselves to their entire tuition on a weekly basis. Should you decide to keep your child home for any reason, you will be required to pay your entire tuition in full for that period of absence as part of your contractual weekly arrangement with us. Your child cannot re-enter the center without this payment in full. Attorney's fees and cost for collections: Parent herein agrees that in the event Soleil Early Learning Academy is forced to take any action to collect any amount of unpaid tuition. Then, and that event, the parent will be responsible and hereby agrees to reimburse Soleil Early Learning Academy for any attorney's fees, filing fees, and/or cost associated with any collection efforts made by Soleil Early Learning Academy either individually or through its legal counsel, against parent.
